### FitNetWork Privacy Policy

Protecting your private information is our priority. #### **Collection of your Personal Information**

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through FitNetWork's public message boards, this information may be collected and used by others.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. - Debug to identify and repair errors that impair existing intended functionality;
